THE FOSTER PROGRAM PROVIDED TEMPORARY HOMES FOR 3,169 CATS AND DOGS WHO WERE TOO YOUNG OR WHO NEEDED A LITTLE MORE TENDER LOVING CARE BEFORE BEING PLACED FOR ADOPTION. THE LEAGUE'S PET FOOD BANK, PEGGY'S PANTRY, PROVIDED FREE FOOD AND SUPPLIES TO 12,696 ANIMALS WHOSE OWNERS WERE STRUGGLING FINANCIALLY.
