THE FOSTER PROGRAM PROVIDED TEMPORARY HOMES FOR 3,206 CATS AND DOGS WHO WERE TOO YOUNG OR WHO NEEDED A LITTLE MORE TENDER LOVING CARE BEFORE BEING PLACED FOR ADOPTION. THE PET FOOD BANK, PEGGY'S PANTRY, PROVIDED FOOD AND SUPPLIES TO 4,769 ANIMALS WHOSE OWNERS WERE STRUGGLING FINANCIALLY.
