Peggy Adams Animal Rescue League provided care and shelter for 5,660 lost, injured and homeless dogs and cats in 2024 and found forever homes for over 5,000 animals through its adoption program.

The foster program provided temporary homes for 3,870 cats and dogs who were too young or who needed a little more tender loving care before being placed for adoption. The Safety Net Program, provided 447,000 animal meals and supplies through Peggy's Pantry Food Bank, and temporary housing and/or medical care to 530 animals whose owners were struggling financially.

Peggy Adams Animal Rescue League performed 13,720 spay/neuter surgeries in 2024. Of these, 283 dogs and 4,770 cats were spay/neutered, vaccinated and microchipped at no cost to the community through grant funding. The league's clinic provided affordable vaccinations to 6,093 cats and dogs.
