Simon Our Cover Model

Simon, a young cattle dog mix, arrived at Peggy Adams through an urgent rescue request from Okeechobee County Animal Control. Simon had been diagnosed with parvovirus, a highly infectious disease. The county facility didn't have the space or resources to treat him, so timely rescue was imperative. Left untreated, parvo often causes severe illness, and even death. Thankfully, we had a new treatment in our arsenal. In 2024, a Canine Parvovirus Monoclonal Antibody treatment became available to veterinarians. This breakthrough treatment is the first ever to stop the virus itself rather than treating its symptoms. When we heard about Simon's case, we rushed him to Peggy Adams to begin treatment as soon as possible. He received his monoclonal antibody injection just minutes after arriving at the shelter. In our parvo quarantine ICU, Simon steadily regained his strength. After a week of care, Simon had overcome the virus completely. Our veterinarians believe Simon's survival and speedy recovery are thanks in large part to the breakthrough treatment. Shortly after he was declared parvo-free, Simon was adopted!

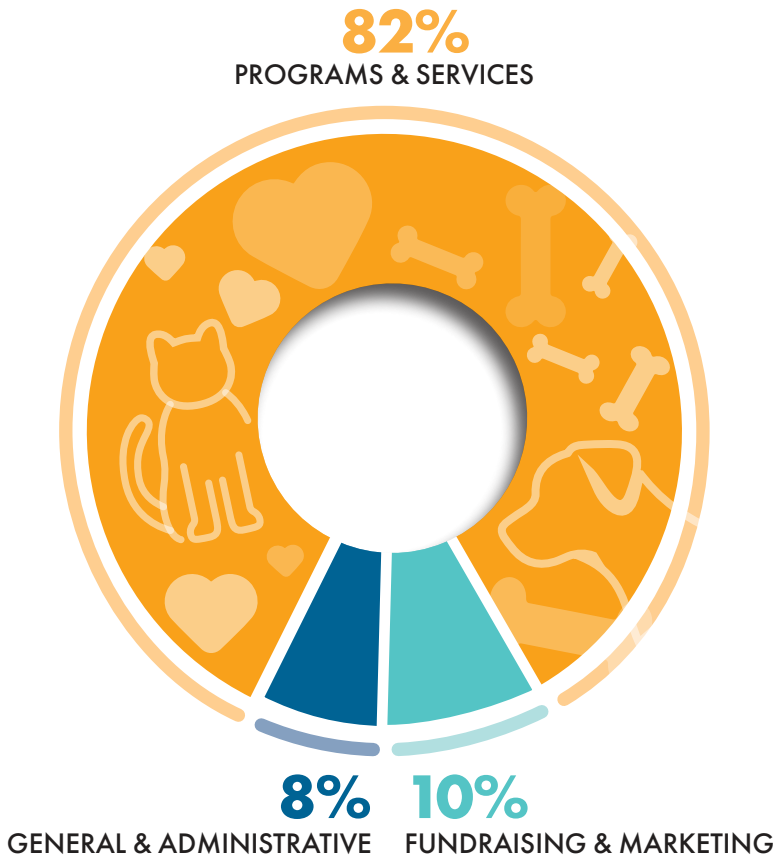

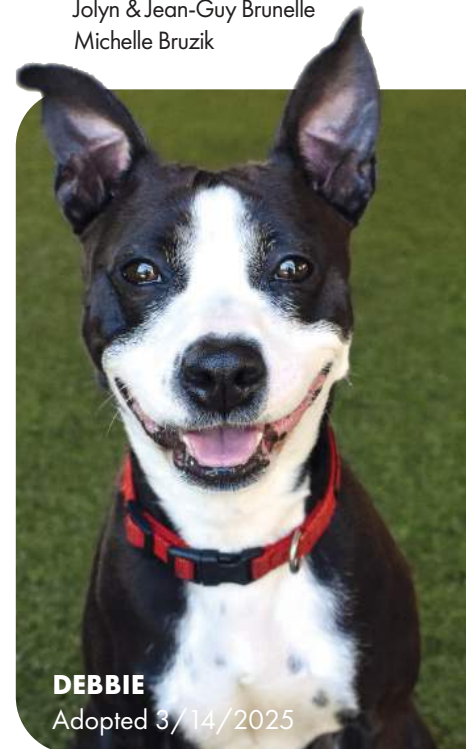
