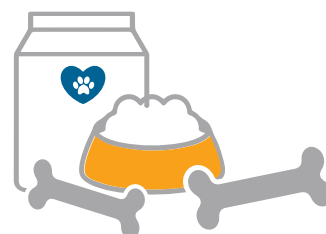

When tiny kittens **Parton and Minaj** arrived at our local municipal shelter without their mother, their future was uncertain. As neonatal kittens, they were far too young to eat on their own and needed round-the-clock care.

Through an urgent rescue partnership, the kittens came to Peggy Adams Animal Rescue League, where foster volunteer Maggie welcomed them into her home. Caring for neonatal kittens means providing frequent feedings, monitoring their growth, and showering them with plenty of love. With guidance from our foster team, regular veterinary checkups, and all the supplies provided by Peggy Adams, Maggie had everything she needed to help the tiny pair grow stronger each day.

Over the following weeks, Parton and Minaj grew stronger with each passing day. What began as a fragile start, soon blossomed into a story of resilience, as the kittens transformed into playful, affectionate, best friends. When they were finally ready for adoption, Parton and Minaj received the happiest result possible; they were adopted together! Their journey is a testament to the lifesaving impact of foster care and our dedicated community of volunteers, staff, and supporters who make stories like theirs possible.
