Peggy Adams Animal Rescue League provided care and shelter for 5,400 lost, injured and homeless dogs and cats in 2025 and found forever homes for over 5,000 animals through its adoption program.

The foster program provided temporary homes for 2,050 cats and dogs who were too young or who needed a little more tender loving care before being placed for adoption. The Safety Net Program, provided 561,650 animal meals and supplies through Peggy's Pantry Food Bank, and temporary housing and/or medical care to 890 animals whose owners were struggling financially.

Peggy Adams Animal Rescue League performed 14,700 spay/neuter surgeries in 2025. Of these, 540 dogs and 5,500 cats were spay/neutered, vaccinated and microchipped at no cost to the community through grant funding. The league's clinic provided affordable vaccinations to 5,274 cats and dogs.

Peggy Adams Rescue League reunited 138 lost pets with their guardians. A total of 35,000 animals benefited from the programs and services of Peggy Adams Animal Rescue League.
